### 2. DATA PROTECTION

Data protection refers the protection of personal data. This is any information relating to you as an identified or identifiable natural person (so-called data subject). This includes details such as your name, postal address, email address or telephone number, but also other information that you provide to us when using Maxi Zoo online store.

### 3. DETAILS OF DATA PROCESSING

Below you will find an overview of which personal data we process from you for which purposes, on which legal basis and whether we transfer this data to third parties in certain cases. If you do not provide us with your personal data, although we want to collect it in order to fulfil a contract with you or to process an enquiry or an order from you, or because we are legally obliged to do so, we may have to refuse your order or may not be able to fulfil our contractual obligations to you. Where we have relied upon our legitimate interests to process your personal data, we have carried out a balancing test in advance of any such processing. #### 5. DATA TRANSFER TO THIRD COUNTRIES

We process your personal data only within the European Economic Area (EEA).

If, in the future, data is transferred to bodies whose registered office or place of data processing is outside the EEA, we will ensure prior to the transfer that the data transfer is covered by a legal authorization and that there are safeguards for an adequate level of data protection in relation to the data transfer (e.g., through the agreement of contractual clauses, officially recognised regulations or internal binding corporate rules at the recipient's premises) or that you have given your consent to the data transfer.

In these cases, we will inform you about any such data transfer in this privacy policy, by reference to (i) the categories of personal data transferred; (ii) the jurisdiction to which they are transferred; and (iii) the mechanism used to safeguard any such transfer.

Where the data transfer is carried out on the basis of Article 46, 47 or 49 para. 1, second subparagraph, of the GDPR, you may obtain from us a copy of the safeguards for the existence of an adequate level of data protection in relation to the data transfer.

## 6. STORAGE PERIOD

We store your personal data as long as it is necessary for the fulfilment of our contractual and legal obligations.

If your personal data are no longer required for the fulfilment of contractual or legal obligations, they will be deleted, unless their - temporary - further processing is necessary for the following purposes:

- Fulfilment of legal, in particular commercial and tax law retention obligations, which may arise, for example, from the German Commercial Code (HGB) or the German Fiscal Code (AO). The retention and documentation periods specified there are generally two to ten years.
- preservation of evidence within the framework of the statutory limitation provisions. According to sec. 195 et seq. of the German Civil Code (BGB), these limitation periods can be up to 30 years, with the regular limitation period being 3 years.

## 7. RIGHTS REGARDING THE NEWSLETTER DISPATCH

## 8. DATA SUBJECT RIGHTS

You have the right at any time, within the limits provided by law,

- to **withdraw** your consent pursuant to once given, as set out in Art. 7 para. 3 GDPR;
- to request **access** to the personal data processed concerning you pursuant to Art. 15 GDPR;
- to request the **rectification** of inaccurate or incomplete personal data stored by us about you pursuant to Art. 16 GDPR;

- to request the **erasure** of the stored personal data pursuant to Art. 17 GDPR, unless the processing is necessary for exercising the right of freedom of expression and information, for compliance with a legal obligation, for reasons of public interest or for the establishment, exercise or defence of legal claims;
- to request the **restriction** of the processing of personal data pursuant to Art. 18 GDPR;
- **to receive** the personal data you have provided in **a structured, commonly used and machine-readable format** or to request that it is **transmitted to another controller** pursuant to Art. 20 GDPR; and
- **to lodge a complaint with a supervisory authority** pursuant to Art. 77 GDPR, if you consider that the processing of your data has been carried out unlawfully and is in breach of the GDPR. As a rule, you can contact the supervisory authority of your usual place of residence or our company headquarters. In Ireland, the competent supervisory authority is the Data Protection Commission, 21 Fitzwilliam Square South, Dublin 2, D02 RD28 Ireland and you may contact them using their contact form available [here](#).

#### **Objection** pursuant to Art. 21 GDPR

Pursuant to Art. 21 GDPR, you have the right to object to data processing by us at any time on grounds relating to your particular situation, insofar as this is based on the protection of "legitimate interests" pursuant to Art. 6 (1) (f) GDPR. If you exercise your right to object, we will cease processing unless we can demonstrate compelling legitimate grounds for further processing which override your rights and interests.
